## Sharing in Ministry Progress

As of September 30, 2014 deposits, \$1,395,950 has been committed by 5,288 donors. This is 46.53% of the appeal goal of \$3 million. \$935,768.37 has been paid toward goal (31.19%). What amazing generosity in giving with a grateful heart!

Two parishes, St. Paul the Apostle, Fort Worth (105.24%) and St. Maria Goretti, Arlington (101.58%) have surpassed 100% of their parish goal in total commitments, with 21 parishes over 50% of their parish goal - St. John, Strawn (97.93%); Holy Rosary, Cisco (91.26%); Most Blessed Sacrament, Arlington (88.84%); Sacred Heart, Seymour (86.69); St. Peter the Apostle, Fort Worth (79.53%); Blessed John Paul II, Denton (79.41%); St. Mary, Henrietta (77.44%); Holy Family of Nazareth, Vernon (76.97%); Christ the King, Iowa Park (74.56%); St. Jude Thaddeus, Burkburnett (73.11%); Santa Rosa, Knox City (66.31%); Immaculate Heart of Mary, Abbott (65.60%); Holy Trinity, Azle (64.25%); Our Lady Queen of Peace, Wichita Falls (63.86%); St. Michael, Bedford (62.87%); Good Shepherd, Colleyville (59.03%); St. Bartholomew, Fort Worth (55.83%); St. Boniface, Scotland (54.63%); St. Joseph, Arlington (53.38%); St. Andrew, Fort Worth (51.18%) and St. Joseph, Rhineland (50.99%).

## Appreciation

## Letter from the Bishop

Bishop Olson's first letter inviting participation in the appeal was sent to households in earlyto-mid September. His follow-up letter to those yet to make a gift will arrive in households in mid-November.

### Parish Share

Each parish will receive 10% of all funds raised up to their parish goal and 50% of everything contributed over the parish goal for use in meeting local parish needs. This share portion is tax-exempt. Checks will be sent to parishes after December 2014 reconciling and again after June 2015 reconciling. A total of \$86,722.03 has already been earned by 86 of 91 parishes.

#### Reminders and Gift Acknowledgement

Donors who requested monthly payment reminders should receive their reminder mailing the first week of every month from November 2014 through June 2015. Recurring credit card and direct debit transactions are completed twice per month. Thank you letters will be sent once per month. Tax documentation for gifts will be included in the Advancement Foundation consolidated tax statement sent to donors in late January 2015.
